Provider Referral Process

- Call to Mary Washington Healthcare—540.741.2580 provider designated line (please do not provide to patients or non-providers)
- Provide the following information:
 - Patient information—name (first, last), DOB
 - Date when COVID-19 test obtained and confirmation of positive test
 - Date of symptom onset
 - Call back number (include alternate call back number if office will be closing)
- MWHC Health Link (HL) RN will return call to provide screening for eligibility (see below)
- **Must be within seven days of symptom onset***
- Fax following requested documents to 540.741.2583
 - Designated order-set
 - Patient demographic face sheet (to include insurance information)
 - Positive PCR test result

COVID-19 + Patients at Risk

- > 65 YO
- **BMI > 30***
- CKD
- Diabetes mellitus
- Immunosuppressive disease history or treatment
- COPD/Chronic Respiratory disease
- Cardiovascular disease
- Hypertension

Pediatric COVID-19 + Patients at Risk

- > 12 YO-18 & >40 KGS WHO ARE **HIGH RISK**
 - BMI >85TH percentile per age/gender
 - Sickle cell disease
 - Congenital/acquired heart disease
 - Neurodevelopmental disorders
 - Immunocompromised state (eg. Trach, G-tube, NIV)
 - Asthma or Chronic Respiratory

MWHC RN will contact patient within 24-48 hours.

Mary Washington Healthcare Monoclonal Antibody Infusion Process

Monoclonal Antibody Treatment Indications

- High risk patients for progressive disease with mild to moderate COVID-19
- *Not for those requiring hospitalization, hypoxic, or requiring new or increase in oxygen (from baseline)
- *Special considerations need to be made for fully vaccinated patients

Special Considerations

- ***Fully vaccinated patients with positive COVID-19 PCR**
 - Evaluate for history of COVID-19
 - **Affirm** >2 weeks from completion of vaccine schedule (from **2nd** dose or from initial J&J dose)
 - Consider underlying risks (e.g., immunocompromised hosts)
 - Rule out other causes for symptoms
 - Rare hospitalizations seen in fully vaccinated patients even with variants
 - HL Screening RN will consult with infectious disease team Team as to appropriateness of monoclonal antibody (mAb) if fully vaccinated
 - Choice of monoclonal antibody will be adjusted with variant tracking prevalence
